#### **Introductions and General Business - Kevin O'Beirne:**

- Introduction by all attendees.
- The Pointer Association's objective is to build upon the momentum of the past couple of years. We are growing the board membership and involvement.
- Explained to new people about how the Gala is every 5 years. Non-Gala year fundraising events.
- Meet 2<sup>nd</sup> Monday of each month and we try to move through meetings quickly.
- Board positions have been filled but other positions are still available. You are encouraged to be involved and team up with someone.
- There have been a number of activities already. MAD days, campus beautification, teacher welcome back lunch and the kick-off event.
- Fitness Center completed and now open with a dedication at the kick off event.
- Explained AAA funding and Gifts & Grants funding.
- Discussed how \$6500 allocated to a locker room attendant is not needed anymore. John Murphy would like to allocate that money to other sports activities. He would like to support the under-funded sports such as field hockey \$2000. He would like to also use \$2000 for a trainer. He would like \$1500 for miscellaneous needs such a referee fees. \$1200 for golf. Discussed if the money should be given to athletics or moved to another PLHS need.

**<u>VOTE:</u>** Transfer the remaining Jimmie Johnson Foundation grant (for the Fitness Center) of \$580 to PLHS finance department to manage along with the \$18K that PLHS holds for the final expenditures.

## **Principal's Report - Bobbie Samilson:**

- Enrollment is up and PLHS has a waiting list.
- Great parent support making the first day great.
- Facilities music center is open and thanks to Kari DeRosier. School is looking better with new motion picture studio and soon a new stadium restroom and snack shack.
- All teachers came back, but other staff did not return or have fewer hours.
- Parents are encouraged to hang out on campus to monitor student activities similar to the Correia Corp.
- Fresh and Easy fundraiser starts on Wednesday and ends December 31st. Bring in receipts.
- Big push to get students ready for college. Sarah Brandl, the head PLHS
  counselor, spoke about the upcoming events and seminars to educate students
  and parents.
- Now students can request appointments with counselors via email.

## Treasurer's Report - Barbara Meserve:

- See report. PLHS Pointer Association has approximately \$315K in assets.
- All fund earmarked except for \$21000, which excludes the AAA funding allocations from May 2012.

## V. P. of Programs - Renatte Adler:

- Explained the AAA funds seek proposals from all departments and the AAA funding package attempts to reach all departments. Explained how and what the AAAs funded last year.
- Wishlist.com started last year. We need to publicize website more and get people to use it.
- Gifts and Grants solicitations for needs during the school year. This money is for small immediate needs.
- eScrip has about 84 new families signed up over the summer.

**<u>VOTE:</u>** Increase total allocation from \$9000 to \$12000 for gifts and grants during the 2012-13 school year. Theoretically reducing the AAA funding package by \$3000 at the end of the year.

#### **Fundraising - Maria Gibson:**

• Completed the kick off – added challenge this year with field being finished three days before event. Wanted to raise \$10K in sponsorship – this event brought in \$13100. 65 families joined the class banners by contributing \$100 each. The small auction made \$690. Snack shack made about \$2800. Boosters funded all the items sold in snack shack. **Event had total net proceeds of \$14956.** 

### **Athletic Boosters - Eleanor Snyder:**

- Explained Protect our Pointers money is needed for this year for the athletic trainer.
- Explanation of what the boosters are and how they work together.
- Boosters supported Kick-off by donating all food to snack shack.
- Athletic physicals will be done by Dr. Allen again.

#### **Volunteer Programs - Lucy DeVito:**

- We have over 75 volunteers signed up this year willing to help with various PLHS and Pointer Association tasks.
- Vicki has placed a volunteer sign-up on the PLHS home page
- Attendance is getting volunteers organized and De (Bobbie's Admin) knows how to contact Lucy.

## **Alumni Association - Kim Jessop:**

- Reunions have been going on all summer.
- Updated records are included in new edition of PLHS alumni directory.
- Career speakers for PLHS class will contact alumni to see if any are interested in speaking.
- Alumni website will have a page of deceased alums and sports records page.

## **Athletic Director - John Murphy:**

- Facilities are great. Team rooms are improved and looking great.
- Correia and Dana facilities are moving forward.
- Sports Chalet is working with PLHS with merchandise and will give 3.3% of the sales back to school.
- All fall teams are off and running.

- Currently \$6800 in membership drive to Pointer Association.
- Everyone should go see the student art by the football field.
- District maintenance is fixing up the PAC's stage area and dressing room.
- Sept 27<sup>th</sup> is open house.
